Injury/Accident Liability Waiver

My child is, to the best of my knowledge, physically fit and able to participate in this sport. Any known medical conditions or special circumstances are listed on this form (ex: asthma, allergies, recurring pain, etc...). I understand that certain personal injury risks are inherent to the participation of sport, including gymnastics. The student and the below signed accept and assume all risk of injury associated with participation as of the below date.

I indemnify and hold Wings Gymnastics, its employees and instructors harmless regarding liability for any injury that my child may incur during the course of his/her participation in gymnastics camp activities. If I am not available, I authorize Wings Gymnastics and its employees to seek attention for my child and to execute orders to authorize any emergency medical treatment and transportation which may be required

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious and is believed to spread mainly from person-to-person contact, contact with contaminated surfaces and in the air. The disease reportedly can be spread by individuals who are infected and show no symptoms. There is no treatment, vaccine or cure for COVID-19, which evidence shows the disease can cause serious life-threatening illness and even death.

Wings Gymnastics, LLC (Wings) has put in place preventative measures to reduce the spread of COVID-19 ("The Wings SSS Plan") and to enforce the Sanitization, Social Distancing and Safety of our participants. Wings Gymnastics, LLC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Furthermore, attending our in-person classes can increase your risk and your child(ren)'s risk of contracting COVID-19.

Assumption of Risk: I acknowledge the contagious nature of the coronavirus/COVID-19 and that the CDC and many local health authorities still recommend practicing social distancing. I voluntarily assume the the risk that my child(ren) and I may be exposed to or infected by COVID-19 while utilizing Wings' services and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed or infected by COVID-19 at Wings may result from the the actions, omissions, or negligence of myself and others, including but not limited to Wings' employees, volunteers, program hosts and lessors, participants and their families.

Waiver of lawsuit/Liability: I hereby forever release and waive my right to bring suit against Wings Gymnastics, LLC, its owners, employees, hosts and lessors, or any other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Wings' services and premises. I understand that I also waive my right to bring any claims including any injury to my child(ren) or myself (including but not limited to, personal injury, disability and death), illness, damage, loss of any kind, including but not limited to claims of negligence and claims of damage, whether known or unknown.

I have received a copy of the Wings SSS Plan, based on the current CDC guidelines and local health authorities' recommendations and Phase guidelines for the prevention of spread of COVID-19. I understand that the Wings SSS Plan's current guidelines may change in accordance with the CDC and local health authorities' guidelines. I understand that I can direct any questions regarding this waiver/release or the Wings SSS Plan to the administrators of Wings Gymnastics, LLC.
